## Target groups

The project addresses the following needs of our participants and **target groups** and will create lasting impact for them:

- a) **REFUGEES** and newly arrived **MIGRANTS** who need high quality, culturally-sensitive orientation/education to enable them to flourish in their new community.
- b) **ADULT EDUCATION PROVIDERS** (community organizations, local authorities, VET providers) who require more effective approaches to cater to the learning needs of refugees and asylum seekers and training opportunities for staff.
- c) **EDUCATION AND SOCIAL DEVELOPMENT POLICY MAKERS AND FUNDERS** who need to identify high performing education strategies for refugees and find tangible ways to support their uptake at national or international level. They need improved integration outcomes for refugees to ensure communities are strengthened and not undermined by marginalization or radicalization.



## Expected results

The PROMISE consists of the following tangible results, to be produced in the form of intellectual outputs:

- **I01 Interagency Networks** and Action Plans enable organizations in host communities to better plan their support structures and training activities in coordination with other actors. The Plans will include directories of organizations and services, outline of areas of responsibility, guide impact evaluation activities and create shared learning opportunities.
- **I02 Social Inclusion Toolkit** presents best practice from across the EU which educators can replicate or adapt in their own communities. Approaches will be organized thematically - education, labour market, civic participation, daily life - but transversal issues will be highlighted, e.g. gender differences, mental health, host community involvement etc.
- **I03 PROMISE OERs for service providers**: a set of integrated multimedia resources organized around a our framework which provides adult education providers with the structure, example learning activities and suggested content to deliver comprehensive, effective intercultural training.
- **I04 PROMISE Online resources**. A multilingual web based platform optimised for tablet and smartphone access that can be used directly by refugees and migrants

## Interagency Networks

Since the beginning of the project, the partners have created Interagency Networks in Ireland, Turkey, Italy, Germany, Spain in order to develop mechanisms for sustainable collaboration between organizations and stakeholders providing integration services to refugees and recently-arrived migrants so that they may plan their support structures and training activities in coordination with other actors.

## Interagency Network Meetings

Each partner has formed Interagency Network in their regions and organized meetings with the stakeholders. Partners have established actions, assigned responsibilities and made the necessary arrangements for the meetings.

### Interagency Network Meetings by RIDC

Four network meetings were organized by Roscommon LEADER Partnership, Ireland on 8<sup>th</sup> Nov. 2018, 12<sup>th</sup> Dec. 2018, 23<sup>rd</sup> Jan. 2019 and 4<sup>th</sup> April 2019 with the participants from The Dept. of Justice & Equality, The dept. of Children & Youth Affairs, Tusla - The Child & Family Agency, Galway Roscommon Education & Training Board, EROC Ballaghaderreen, Roscommon County Childcare Committee, The Irish Refugee Protection Programme, Ballaghaderreen Family Resource Centre and various other representatives of inter-related agencies/services.



### Interagency Network Meetings by Tuzla Kaymakamligi

The project experts from Tuzla Kaymakamligi, Istanbul, Turkey organized two interagency network

### Interagency Network Meetings by KulturLife

KulturLife, Germany organised three network meetings so far. These include meetings with the ZBBS (Central Education and Counselling Centre for Migrants), the ZEIK (center for empowerment and intercultural creativity) on 30<sup>th</sup> April and the Schusterkrug (a shared accommodation for asylum seekers in Kiel) on 16<sup>th</sup> May. We also met on 22<sup>nd</sup> May with BEI (Bündnis Eine Welt Schlesig-Holstein).

## Kick-off meeting

The PROMISE project kicked off in Roscommon, Ireland on 30<sup>th</sup> and 31<sup>st</sup> October 2018, Roscommon LEADER partnership held the meeting in their offices in Roscommon and representatives were there from all of the partner countries. This meeting was the perfect way for everyone to get introduced to each other and to begin what will be a productive and effective partnership!

The meeting was hosted by the project coordinator, Roscommon LEADER Partnership (Ireland). The representatives from Tuzla Kaymakligi - District Governorship (Istanbul - Turkey), Momentum Consulting (Ireland), Canice Consulting Limited (Northern Ireland), KulturLife (Germany), CEBANC (Spain) and Frontiera Lavoro (Italy) were gathered for two-day meeting in order to discuss about the quality management and impact evaluation strategy, dissemination & sustainability strategies, IPR agreement, to identify the basic principles, tasks, methods and strategies for developing the action plan in order to address the intellectual outputs, activities and the events in the following months.

The participants also visited Ballaghaderreen Emergency Reception and Orientation Centre where asylum-seekers and refugees fleeing war, mostly from Syria are accommodated.

During the project meeting the participants discussed the impact+ model - enabling partners to develop a shared understanding of the expected results and long term impact of the project, as well as methods for data collection.

With very constructive discussions, many thoughtful and also practical comments from the representatives, the meeting was a great success and was a key for the smooth project start.

The 2<sup>nd</sup> transnational project meeting will be held between 16-17 May 2019 in Kiel, Germany. The partner meeting will be hosted by the project partner, KulturLife.
